1. NAME OF THE TRUST:

The name of the shall be 'GRAMODAYA EDUCATIONAL TRUST' and Its Head Office shall be at VILL. & POST-RAMPUR SARDHA, DISTT.- FAIZABAD and branch (es) such other place or places as the trustees herein may decide from time to time.

2. FOUNDER TRUSTEES:

3. **PRESIDENT:**

- 3.1 Sri Narbadeshwar Singh shall be designated as the life President, who shall be in charge of the day to day affairs of the Trust.
- 3.2 The 'President shall have power to administer the funds of the trust and any power exercisable by the Board of Trustees as may be delegated to the President.
- 3.3 The president shall hold office for life or until he resigns there from.
- 3.4 The post of president shall be succeeded by Deepak Singh, the youngest son of Sri Narbadeshwar Singh. However it has been more fully described in para no. 14 of by-laws of the trust.

4. **Trust Fund:**

- 4.1 The Initial contribution of Rs. 11,000/- (Rs. Eleven Thousand only) made be author of the trust shall hereby vest in the trustees and shall constitute the initial trust fund.
- 4.2 The trust fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.
- 4.3 That the Trust Fund can be applied for any charitable purpose other than those specified in Para 5 here in below.

7. **Eligibility of members:**

No. Person being :

- An undercharged insolvent; or
- Convicted of an offence involving moral turpitude ; or
- Of unsound mind; or
- A minor

shall be eligible to be a trustees.

8. **Ceasing of membership:**

A persons shall cease to be a trustee in any of the following events:-

- If he dies; or
- If the becomes bankrupt; or
- If the becomes insane or otherwise becomes incapable to act; or
- If the resigns his office
- On the recommendation of managing committee any member other than president can be terminated.
- Any other matter is to be or may be provided in the interest of the trust.

9. **Manaqing Committee:**

10. **Meeting:**

General meeting of the Managing Committee shall be held at least once in a year. However with the consent of President, at any time meeting can be called upon.

11. **Period of Notice:**

Notice period shall be minimum of 7 days. However it can be reduced on the events of any emergency, with the consent of President.

12. **Quorum:**

Presence of 1/3 members of the Managing Committee shall be quorum. In case present members are less than 1/3, the meeting shall be adjourned for the next week on the same day, same place and same time, for which no quorum shall be required.

13. **Duties & Rights of Managing Committee:**

- Nomination of Vice- President, Secretary, Joint secretary and Treasurer.
- Preparation of Budget.

- c) Approval of Expenses.
- d) Approval of Income & Expenditure Account, Balance Sheet and auditors Report thereon.
- e) Modification of constitution of the trust.
- f) To appoint Auditors.
- g) To take decision in respect of opening of Hospitals, Schools, Colleges, Graduate & post Graduate College, Engineering/Management/ Medicals colleges/Technical Institutions, Polytechnics, ITI, University, Para Medical colleges, Teachers Training Colleges etc.
- h) Managing Committee shall have right to form sub committee for any Institution(s) in which all the members of Managing Committee shall be the member of sub committee and additional members so for opted outside the family shall have no voting rights but they can provide their opinion to run the institution and shall participate the meeting.
14. **President:**
- a) President of the Trust shall be Narbadeshwar Singh then his youngest son Deepak Singh and thereafter the president of trust shall be his wife then eldest son of Deepak Singh.
- b) In case there is no surviving male member in the family of Sri Deepak Singh then the eldest legal heir shall become the President of the Trust.
- c) In case legal heir mentioned as above is minor, then any trustee outside the family having Longest tenure shall occupy the chair of President till attainment of the age of majority of the legal heir.
15. **Rights & Duties of President:**
- a) The President shall be the principal officer of the Trust.

- b) The President shall have right to take any decision in the interest of the Trust.
- c) The President shall preside the meeting of Managing Committee and in his absence eldest member shall preside the meeting.
- d) The President shall nominate and appoint the vice-president, secretary, treasure, joint-secretary and also to create any post and to fill up such post.
- e) The President shall operate bank accounts singly or jointly with Secretary/ Treasurer or any person duly authorized by him.
- f) The President shall have the right to receive donations, corpus fund, properties, fund,

and on behalf of the trust.

- g) The President's decision in any dispute will be final and binding on all.

16. Vice President:

In the absence of President he/she will act as President.

17. Right & Duties of Secretary:

- a) Secretary shall operate and execute all working of the trust under the instruction of president.
- b) He/She will keep and maintain minute's books of the meeting.
- c) He/She will keep and maintain members register of the trust.
- d) He/She will carry on all the working of the trust on the instructions of the President.
- e) He/She will operate the bank account jointly with President or Treasurer.
- f) He/She will keep and maintain all the funds, securities, deeds which are property of the trust in safe under his/her custody and he/she will be responsible for all such properties.

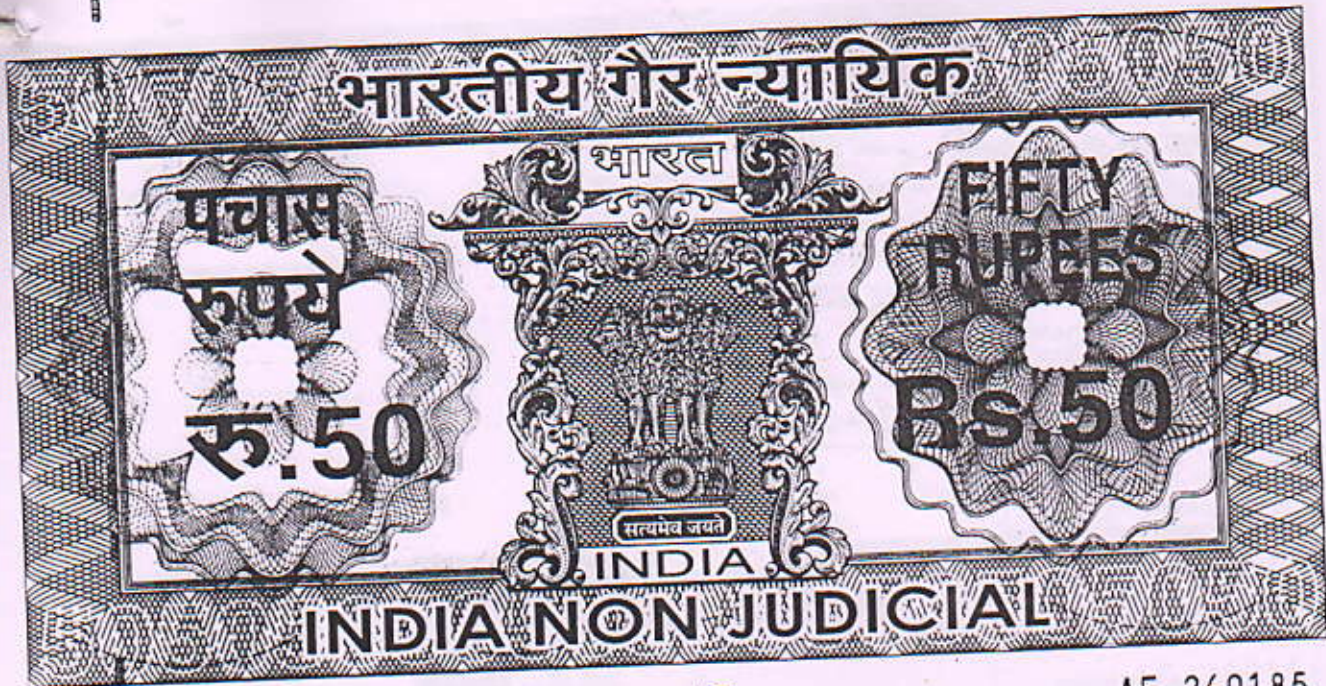

18. Joint Secretary:

In the absence of Secretary, he/she will act as Secretary.

19. Treasurer:

- a) Shall keep and maintain the books of accounts, vouchers, bank book, stock register etc of the trust.
 - b) Shall carry on other business under instructions of the President.
 - c) Shall operate Bank Account(s) jointly with President and /or Secretary under instructions of the president.
20. Proper accounts for the Trust shall be kept at the Head Office of the trust.
21. The Managing Committee members will not be entitled to receive any remuneration but the Managing Committee members may reimburse themselves all expenses actually incurred by them In connection with the trust or there duties relating, thereto.
22. The Managing Committee on the recommendation of President for the time being will be at liberty to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.
23. Every, Trustee will be at liberty to resign on giving one month's notice of his/her intention to do so.
24. The Managing Committee may from time to time frame rules for the conduct and regulation of the meetings of trustees. In the absence of such regulation:-
- a) All matters will be decided mutually by the managing Committee.
 - b) Resolution passed without any meeting of the Managing Committee but by circulation thereof and evidenced in writing under the hands of one third of the trustee including President shall be as valid and effectual as a Resolution duly passed at a meeting of managing Committee.

27. The Head office of the Trust shall be situated at Vill. & Post- Rampur Sardha, Distt. - Faizabad (U.P.) unless changed by the life Trustees by two third majority.
28. The objects and/or Bye-Laws of trust can be altered or modified or changed within the Charitable purposes on the recommendation of president in General Meeting of the Trustees.
29. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for the benefit of any trustee/member or for any purpose which is not a charitable purpose in law and all provisions here of shall be constructed accordingly.
